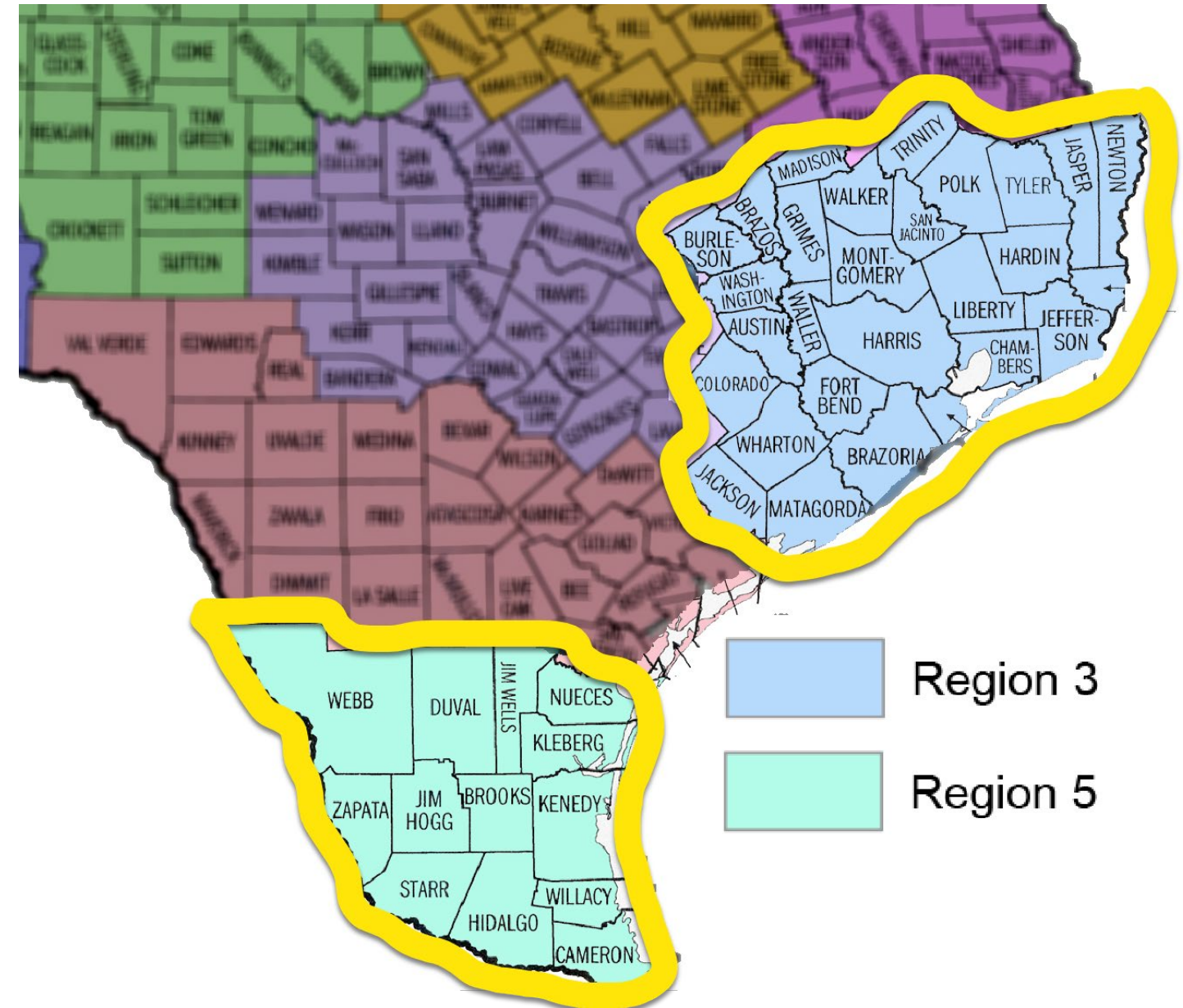

- All **SY23-24** requisitions must be placed in WBSCM.
- FDP Module in TX-UNPS will **not be available for the Pilot Group for SY23-24** (no back up surveys, etc.). Be sure to attend and complete WBSCM training.
