Dear Contracting Entities:

The Texas Department of Agriculture (TDA) is committed to providing you the most pertinent information regarding the impacts of the federal government shutdown on operations as it relates to TDA administered federal nutrition programs.

TDA has evaluated the availability of funds for each nutrition program and estimated the period of time the agency anticipates being able to pay Contracting Entities (CE) claims for reimbursement based on historic claims data. All TDA administered federal nutrition programs are reimbursement programs dependent on the availability of federal funding. TDA's current level of available funds is estimated to be able to pay claim reimbursements received in our office by the months indicated in the chart below.

Please note that the funding coverage end dates information is based on the current rate of claims and on a claim paid based on its filing date and not on the date of service. Also, the availability of TEFAP funds may be affected by Trade Mitigation Administrative Expenses which may now be charged to TEFAP funds.

TDA Food and Nutrition CEs should review the impact of the federal government shutdown on their business operations. Should claim funding lapse, CEs have the option to utilize non-federal funds to fund program operations. Should the agency be authorized to retroactively pay claims for meals served or program costs for which contracting entities were not previously reimbursed, continued compliance with program regulations, including meal pattern requirements, must be maintained to be eligible to claim and receive applicable reimbursements. However, TDA cannot anticipate under what scenario funding may or may not be approved.

Funding to support the administrative functions of the agency is a separate funding source. Based on the current funding available, TDA anticipates it will continue all standard agency functions through June, 2019. Therefore, TDA and the Education Service Centers will continue to provide support to program operators, maintain all application and administrative timelines, conduct a full administrative review schedule(s) and continue to host planned conferences and training. These activities and agency responsibilities are funded separate and apart from accounts that pay CE claims.

TDA will continue to provide updates regarding funding estimates and all other information as it becomes available.
