## Executive Summary

In 2011, Texas law mandated that public school districts with **60** percent or more of their students eligible to receive free or reduced-price meals in the National School Lunch Program (NSLP) participate in the Summer Nutrition Programs (SNP)<sup>1</sup> or request waiver from participation. In 2011, 494 school districts were identified as mandated to offer a SNP, of which 341 (69 percent) offered an SNP.

In 2012, a new Texas law mandated that public school districts with **50** percent or more of their students eligible to receive free or reduced-price meals in the National School Lunch Program (NSLP) participate in the Summer Nutrition Programs (SNP), arrange for the operation of a SNP, or request waiver from participation, per Senate Bill 89 (82<sup>nd</sup> session). In 2012, 733 school districts were identified as mandated to offer a SNP, of which 493 (67 percent) offered an SNP or arranged for the provision of an SNP. 253 waivers were requested in 2012, of which 240 (95 percent) were granted by Texas Department of Agriculture (TDA). The remaining 13 school districts offered an SNP.

In both fiscal years 2011 and 2012, all school districts required to participate in a Summer Nutrition Program participated in the program or received a waiver to program participation. This represents an increase in compliance with summer mandate requirements; in 2009 and 2010 21 and 14 districts respectively did not comply with this requirement.

In compliance with SB 89, school districts that participated in a SNP were asked to report to TDA the total cost of operating their summer nutrition program once it has concluded, as well as any other funds (other than Federal funds) that were used to pay for the operation of a summer feeding program. School districts used various funds to offer SNP such as general funds and child nutrition revenue funds.

Challenges remain for districts as the number of districts granted waivers from their obligation to participate in an SNP has risen, from 93 in 1997 to 240 in 2012, and the overall percentage of mandated district waivers is up, from 26 to 33 percent. According to those requests, transportation cost is the single largest obstacle keeping school districts from participating, representing 34 percent of the waivers in 1997 and 36 percent in 2012. Other reasons for waiver requests include:

- Enrollment includes fewer than 100 children eligible for the National free or reduced price School Lunch Program
- School buildings or cafeterias are under renovation or construction
- Extenuating circumstances
- The cost to the district to provide or arrange for provision of a program would be cost-prohibitive<sup>2</sup>

## Charge

In 2011, the 82<sup>nd</sup> Texas Legislature passed Senate Bill 89, directing the Texas Department of Agriculture to submit a biennial report regarding participation the summer feeding programs. This requirement replaced Texas Human Resources Code, section §33.024 with Texas Agriculture Code, section §12.0029 under the heading SUMMER NUTRITION PROGRAM, which stated as follows:

(j) Not later than December 31 of each even-numbered year, the department shall provide to the legislature by e-mail a report that, for each year of the biennium:

(1) states the name of each school district that receives a notice under Subsection (c) and indicates whether the district:

(A) has provided or arranged for the provision of a summer nutrition program; or

(B) has not provided or arranged for the provision of a program and did not receive a waiver;

(2) identifies the funds, other than federal funds, used by school districts and the state in complying with this section; and

(3) identifies the total amount of any profit made or loss incurred through summer nutrition programs under this section.

(k) The department shall post and maintain on the department's Internet website the most recent report required by Subsection (j).

## Background

Texas Senate Bill 714, enacted by the 73<sup>rd</sup> Legislature in May of 1993, amended Chapter 33 of the Human Resources Code by adding Section §33.024, Summer Food Service Program (SFSP). The amendment requires school districts with 60 percent or more of their children eligible for free or reduced-price meals in the National School Lunch Program (NSLP) to participate in the SFSP by the summer of 1997. Mandatory participation is required only if federal funds are available to cover the cost of operating the program. School districts can be granted waivers from participation annually if certain conditions stipulated in the legislation are applicable.

Required participation was implemented incrementally by schools on an annual basis, beginning in 1994 with schools having 90 percent of their children eligible and ending in 1997 with schools having 60 percent of their children eligible. Public Law 108-265, the Federal Child Nutrition and WIC Reauthorization Act of 2004, made a number of changes to the Child Nutrition Programs, including provisions for a permanent summer feeding program through the NSLP as well as simplifications to the existing SFSP. Together, the two programs are referred to as Summer Nutrition Programs (SNP).

In 2011, Texas Senate Bill 89, enacted by the 82nd Legislature, amended Chapter 12 of the Agriculture Code by adding Section §12.0029 and repealing Human Resources Code, section §33.024. Senate Bill 89 requires that starting in summer 2012, public school districts with 50 percent or more of their students eligible to receive free or reduced-price meals in the National School Lunch Program (NSLP) participate in the Summer Nutrition Programs (SNP) or request waiver from participation. Further regulations are codified in the Texas Administrative Code, Title 4, Part 1, Rule §25.612.

**Simplified Summer Food Service Program:** Public Law 108-265 also expanded provisions of the 14-state pilot program of the simplified SFSP, which originated in 2001, to six additional states with low participation rates and established permanent simplified cost accounting procedures for all sponsors to include schools and non-profit organizations. The complex reimbursement formulas were replaced with a straight “meals times rate” provision that allowed maximum reimbursement regardless of actual cost. All SFSP sponsors continued to submit budgets with their applications for participation but allowed experienced public and private nonprofit schools an exemption from submitting a budget, if they participated in the SFSP previously and had no operational problems.

**NSLP Seamless Summer Option:** The Child Nutrition and WIC Reauthorization Act of 2004 authorized a Seamless Summer Option through the NSLP as an alternative to the SFSP for schools that already participate in school meal programs and wish to continue meal service into the summer. The Seamless Summer Option operates according to the same procedures followed during the school year except free reimbursable meals must be available for all children 18 years and younger in the area. There is no cost accounting procedure required for public schools electing to operate the Seamless Summer Option, other than those required for operating the NSLP. When the Seamless Summer Option became available, schools that are required to offer summer feeding were given the choice to participate in either the SFSP or Seamless Summer Option to meet the requirement.

In 2007, the Texas Department of Agriculture (TDA) administered the Seamless Summer Option while the Texas Health and Human Services Commission (HHSC) administered the SFSP. As of September 1, 2007, when the administration of both programs came under TDA's purview, TDA became responsible for executing Senate Bill 714, managing the waiver process for mandated participation schools and submitting biennial reports to the legislature in even-numbered years.

## Participation

In 2011, a total of 494 school districts were subject to the requirements of Senate Bill 714 with at least 60 percent of their students eligible for free or reduced meals. Of those 494 school districts, 341 participated in either the Summer Food Service Program or Seamless Summer Option.

In 2012, 733 school districts were mandated to offer a summer feeding program, arrange for the operation of a SNP, or obtain a waiver from the requirement, of which 493 provided summer meals by offering a summer feeding program or arranging for the operating of a summer feeding program.

Mandated school districts are required to work with the state agency to remove barriers to participation, locate alternate sponsors and process waiver requests.

In both fiscal years 2011 and 2012, all school districts required to participate in a Summer Nutrition Program participated in the program or received a waiver, as the following table shows.

## **Waivers**

School districts were granted waivers for the following reasons:

- Enrollment includes fewer than 100 children eligible for the National free or reduced price School Lunch Program
- Transportation is an insurmountable obstacle
- School buildings or cafeterias are under renovation or construction
- Extenuating circumstances
- The cost to the district to provide or arrange for provision of a program would be cost-prohibitive

Attached are four appendices for fiscal years 2011 and 2012:

- Participants – lists of school districts mandated to participate in an SNP that either did participate or were granted a waiver for 2011 (Appendix A) and 2012 (Appendix C)

## Costs

School districts that meet a certain percentage of percent free and reduced eligibility threshold set forth (60 percent in 2011 and 50 percent in 2012) are asked to report to TDA the total cost of operating their summer nutrition program once it has concluded, as well as any other funds (other than Federal funds) that were used to pay for the operation of a summer feeding program. From that self-reported information, TDA has deducted the amount of the federal reimbursements made for that year's program to create the lists of gain/loss, compared to federal funds received, incurred by the school districts and the state in order to comply with this section. Also reported are any other non-federal funds used to operate the programs.

It should be noted that to maintain the required nonprofit status of the National School Lunch Program and the School Breakfast Program, the fund balance or net cash resources of the School Nutrition Program account should not exceed three month's average expenditures; any gains noted below are specific to the operation of a SNP and do not reflect the districts' fund balance or net cash resources as a whole. Should an excess fund balance occur, schools must immediately take steps to reduce the balance or have an acceptable plan for using surplus revenues for school nutrition program purposes, which could include improving food quality or obtaining needed services or equipment.

District costs are given in Appendix B (2011) and Appendix D (2012) for the districts that reported them. TDA did not incur costs above federal funds to comply with Texas Senate Bill 89 (82<sup>nd</sup> Legislature).
