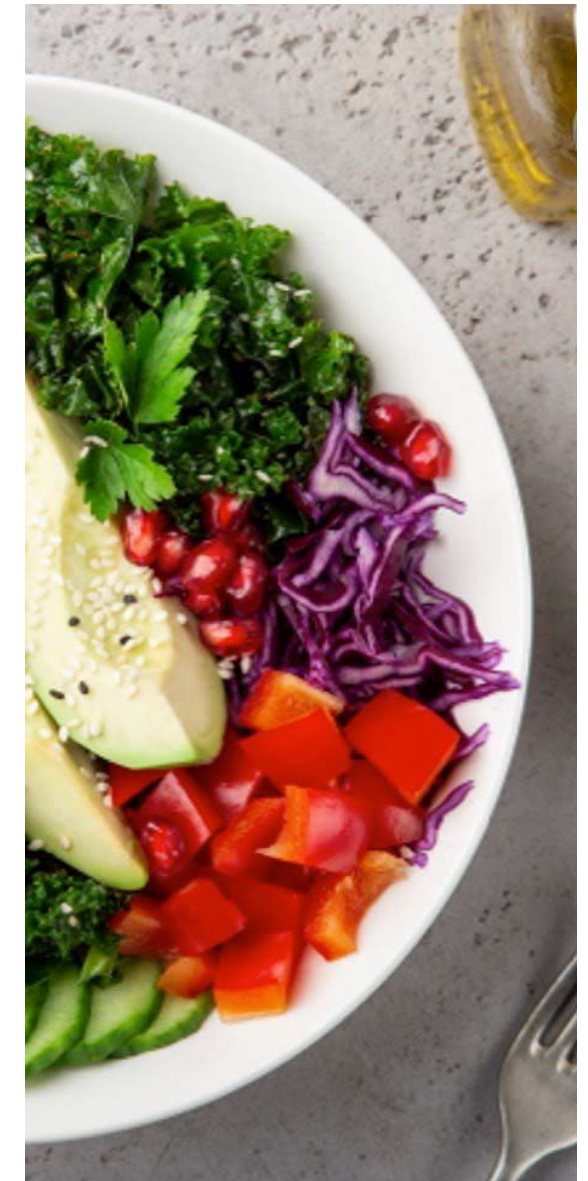

# What is the CEP Report?

- The Community Eligibility Provision [CEP] Report is an annual site-level report of eligibility and enrollment as of April 1.

## IMPORTANT DATES

- **March 1:** CEP Report Opens in TX-UNPS
- **March 5:** March Direct Certification data updated in Texas ELMS
- **March 20:** CEP Report Due in TX-UNPS

## Who is required to submit the CEP Report?

**All School Food Authorities (SFAs) operating the National School Lunch Program and/or the School Breakfast Program.**

This includes CEs operating CEP, Provision 2 and standard counting and claiming sites.

*Only RCCIs are exempt from reporting.*







## What data needs to be reported?

- **Number of enrolled Identified Students (IS) per site.**  
Identified Students – Children who are certified for free school meals without the use of a household application.
- **Enrollment number per site confirmed on the day that the number of identified students is determined.**  
Enrollment – Number of students who are enrolled in and attending schools and have access to at least one meal service daily.

# Where is the CEP Report submitted?

Beginning March 1, CEs can access the Community Eligibility Provision Report in TX-UNPS.

SNP > Applications > Community Eligibility Provision

Reports are due by March 20<sup>th</sup>.





# CEP Final Rule Threshold Change

Effective October 26, 2023, this final rule lowers the **minimum identified student percentage (ISP)** from 40 percent to 25 percent.



# CEP Final Rule – Threshold Change

## TX-UNPS Update

- An update to the system to reflect the threshold change is in progress.
- It is expected to be complete by April 1.

### What does this mean for CEP Reporting?

- *There is NO CHANGE to the data being reported or the submission process.*
- However, the previous threshold percentage will be reflected in the CEP Report screen and eligibility indicators may not be accurate until the update is complete.
- Once the update is complete, the change will be applied retroactively, and eligibility indicators will be corrected.

NATIONAL SCHOOL LUNCH PROGRAM

### Instructions

The Community Eligibility Provision (CEP) for the National School Lunch Program (NSLP) provides an alternative to household applications for free and reduced price meals for economically disadvantaged students in local educational agencies (LEAs) and schools. Sites that elect this option agree to serve all students free lunches and breakfasts for four (4) successive school years and claim the meals based on a percentage of **Identified Students** multiplied by a USDA-defined multiplier factor.

Sites which have an Identified Student Percentage (ISP) of 40% or greater are eligible for this option.  
Sites which have an Identified Student Percentage (ISP) between 30.00% - 39.99% are potentially eligible.
